- 7. SB 1120 By Fields of the Senate**
Oklahoma Alcoholic Beverage Control Act; modifying definition relating to gross receipts tax on mixed beverages. Effective date.

- 8. SB 1138 By Garrison of the Senate**
Oklahoma Motor Vehicle License and Registration Act; creating Prisoner of War and Missing in Action special license plate; creating revolving fund; allowing expenditure under specified circumstances. Effective date.
- 9. SB 1159 By Adelson of the Senate**
Oklahoma Capital Investment Board; modifying amount of tax credits which may be issued or transferred; requiring certain information be included in report. Effective date.
- 10. SB 1230 By Mazzei of the Senate**
Tax administration; modifying licensing and permitting procedures; making certain activities unlawful; providing penalty. Effective date.
- 11. SB 1231 By Mazzei of the Senate**
Tax administration; modifying due dates for submitting various reports and remitting taxes; modifying other procedures. Effective date.
- 12. SB 1232 By Mazzei of the Senate**
Oklahoma Vehicle License and Registration Act; modifying provisions relating to special license plates. Effective date.
- 13. Committee authorization to investigate Oklahoma Horse Racing Commission Nominees.**
